Whereas, it has also come to the knowledge of this office that the Divisional Forest Officers concerned have not taken cognizance of this precedence and allowed the situation to drift away by shirking their responsibilities towards administrative discipline; and

Whereas, such administrative indiscipline cannot be allowed to continue, as it jeopardizes the over-all administration in the department.

It is hereby clarified that Range Officers in the department have no power to transfer any staff member of any level. However, in case any Range Officer feels it necessary to transfer any official in his range, he has to submit a proposal to the competent authority and the order of transfer shall always be issued by the officer competent to do so.

All Range Officers are enjoined upon to strictly follow the instructions and any indiscipline in this regard would be viewed seriously.
